The appointee shall report along with following certificates in original to Directorate of Family Welfare MCH & Immunization J&K at Barzulla Srinagar / Camp Office Nagrota Jammu, within 21 days from the date of issuance of this appointment order failing which the appointee shall forego his right to appointment, and the same shall be deemed to have been cancelled **ab-initio** without any further notice:-

- i. Academic/qualification certificate.
- ii. Matriculation /Date of Birth certificate.
- iii. Health certificate issued by the Chief Medical Officer.
- iv. Domicile Certificate issued by the competent authority.
- v. That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries (DIC) and District Employment & Counseling Centre of the domicile District, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government service. He shall be required to repay the entire loan liability in suitable EMI's to be worked out by the DDO concerned from his salary. DDO concerned

shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery valid relevant Category Certificate (s) if any applicable.

vi. Any other certificates/documents as required under rules/norms.

**The appointment of the candidate shall further be subject to the following conditions:-**

- a. The appointee shall furnish an undertaking in the shape of an affidavit to the effect that if on verification, his qualification/Date of Birth/reserved category certificate from the concerned issuing authorities are found fake / forged his appointment as Junior Health Inspector shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- b. The appointment, in Divisional/District cadre is non-transferable from one Divisional /District cadre to another Divisional/District Cadre.
- c. The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory report in respect of genuineness of qualification/date of Birth/relevant Category Certificate is received from the concerned Authorities/Agency.
- d. The appointee shall be on probation for a period of two years.
- e. The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated. 24.12.2009.
- f. The inter-se-seniority of the appointee(s) shall be determined in accordance with the merit secured by the appointee(s) in the selection list prepared by the J&K Service Selection Board.
- g. The appointment of the above appointee(s) shall be subject to outcome of writ petition(s) if any, pending before competent Court of Law.
- h. The appointee(s) shall be liable for action as warranted under rules for violating any of the laid down conditions as indicated in this appointment order.
