Consequent upon the temporary appointment of Ms. Asmat Amin D/o Mohd Amin Bhutt as **Female MPHW** in the Pay Level-2 (19900-63200) vide this office order No.274-JK(FW) of 2023 dated. 13.06.2023, issued under endorsement No.DFW/JK/Est/App/FMPHW/1558-66 dated. 13.06.2023, on the basis of selection made by J&K Service Selection Board in the Department of Family Welfare MCH & Immunization J&K under **District Cadre Jammu**, as conveyed by the Administrative Department (H&ME) vide above quoted references. Subsequently, the appointee joined this office on 15.06.2023 and is hereby adjusted/ posted against the available vacant post at **Sub. Centre Miran Sahib Block R.S.Pura ,District Jammu.**

The appointee shall report to Deputy Chief Medical Officer's office Jammu within 07 days from the date of issuance of this order, failing which she shall forego her right to appointment and the same shall be deemed to have been cancelled ab-initio without any further notice.

The appointees shall be allowed to join only on the production of following certificates (in original) to be verified subsequently.

- i. Academic/qualification certificate.
- ii. Matriculation /Date of Birth certificate.
- iii. Health certificate issued by the Chief Medical Officer.
- iv. Domicile Certificate issued by the competent authority.
- v. That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the Domicile Distt., He/She shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government Service. He/She shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such self-employment unit/enterprise and recovery to be made and also personally monitor it recovery.

vii. Any other certificates/documents as required under rules/norms.

**The appointment of the candidate(s) shall further be subject to the following conditions:-**

- a. The appointee shall furnish an undertaking in the shape of an Affidavit to the effect that if on verification, her qualification/Date of Birth/Reserved Category Certificates from the concerned issuing authorities are found fake/forged her appointment as Female MPHW shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against his/her; (Performa enclosed).
- b. The salary of the appointee shall not be drawn and disbursed to her unless the satisfactory report in respect of genuineness of qualification/date of Birth/relevant Category Certificate is received from the concerned Authorities Agency.
- c. The appointees shall also furnish an undertaking in the shape of an affidavit to the effect that she is not working in any Govt./Semi Govt. Department/Organization from the date joined in the Directorate of Family Welfare, MCH & Imm. J&K.
- d. The appointee shall be on probation for a period of two years.
- e. The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- f. The inter-se-seniority of the appointee shall be determined in accordance with the merit secured by the appointee(s) in the selection list prepared by the J&K Service Selection Board.
- g. The appointment of the above appointee shall be subject to outcome of writ petition(s) if any, pending before competent Court of Law.
- h. The appointee(s) shall be liable for action as warranted under rules for violating any of the laid down conditions as indicated in this appointment order.
