Sir.

In compliance of Liberalised Pricing and Accelerated National Covid-19 Vaccination Programme w.e.f 1st of May 2021, announced by the Govt. of India, the Union Territory Government of J&K has decided to introduce the new initiative w.e.f. 5th May 2021, where all eligible population between 18-45 years shall be vaccinated.

In pursuance to the above mentioned vaccination strategy and guidelines, the Department of Health & Medical Education, J&K, proposes to procure approximately 1.24 Crore doses of Covisheild in a phased manner within a period of 3 to 4 months w.e.f. 05th of May 2021.

Accordingly, an advance intimation for procurement of 1.24 crore (one crore twenty four lakh) doses of COVISHIELD vaccine (64 lakh for Kashmir Division and 60 lakh for Jammu Division) as per the below given schedule, is being conveyed for timely supplies:

- 1. 5th May 2021 = 40 lakh Doses
- 2. 5 June 2021 = 42 lakh Doses

3. 50 July 2021 = 42 lakh Doses

The detailed terms & conditions of the delivery & payment along with the schedule of supplies may be invoiced and intimated at the earliest. On receipt of invoice alongwith indicated date(s) of supply of vaccines, payment shall be released five days in advance of
