At the outset Dr. Anis Altaf Nabi Chief Medical Officer Poonch welcomed the worthy District Development Commissioner and other members of the designated committee and discusses the present status including initiatives

taken-up, issues and concern of Quality Assurance programme with detail power point presentation.

Agenda of the Meeting:

- **Family Planning indemnity scheme (FPIS):-**Dr. Anis -Altaf- Nabi Chief Medical officer gave brief account on Family Planning indemnity scheme. FPIS is to compensate all beneficiaries of sterilization, doctors, and health facilities (public and accredited private/NGO) conducting sterilization operation in the **unlikely event of death/failure/ complication following sterilization operation.**
- He had a detail discussion on manual "Standards and quality Assurance in sterilization services" especially regarding proceedings in case of Failure / Complicate and death.
- He further remarked that there is no panel of doctors in district Poonch, who perform sterilization operations,

The Chair has directed the committee members to :-

- He asked the Medical Superintendent of Raja Sukhdev Singh District Hospital and all Block Medical Officers to empanel gynaecologists and if required, then schedule training at GMC Jammu/Rajouri, in consultation with Directorate of Family Welfare Jammu. (Action Taken by Chief Medical Officer / Directorate of Family Welfare MCH & Immunization Jammu)
- On the occasion, **Shri Inderjeet (JKAS) District Development Commissioner** has directed to all the health officers to implement National Family Planning Indemnity schemes as soon as possible. (Action Taken by Chief Medical Officer)
- He stressed on District level orientation and other trainings are conducted timely in a meaningful manner. (Action Taken By Chief Medical Officer)
- He suggested to ensure IEC at Block Level and District Hospital Poonch regarding Laproligation Failure compensation.(Action taken

by Medical Supdtt. And Block Medical officers
mandi/Mendher/Surankote)

- Directed to install LED's at District Hospital and SDH Mandi, Mendhar, Surankote for IEC.(Action taken by Medical Supdtt. And Block Medical officers mandi/Mendher/Surankote)
- Directed to ensure report & record of Laproligation Failure cases within stipulated time to State Quality Assurance Committee.
- Meeting ended with the vote of thanks by Chief Medical Officer poonch
